## DIRECTORS' REPORT

for the year ended 30 June 2018

The directors present their report and the audited financial statements for the year ended 30 June 2018.

### Principal Activity and Review of the Business

The principal activity of the company are to promote and advance humanity, health and wellbeing in the community and to educate and provide training to the community about such issues.

The organisation has been granted charitable tax exemption status under Sections 207 and 208 of the Taxes Consolidation Act 1997, Charity No CHY 21993 and is registered with the Charities Regulatory Authority.

The Company is limited by guarantee not having a share capital. There were previously two issued shares but the company purchased its own shares on 23rd March 2017. The shares were cancelled after the purchase.

There has been no significant change in these activities during the year ended 30 June 2018.

### Financial Results

The (deficit)/surplus for the year amounted to €(17,546) (2017 - €7,825).

At the end of the year, the company has assets of €6,926 (2017 - €20,420) and liabilities of €30,440 (2017 - €26,388). The net liabilities of the company have decreased by €(17,546).

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.



# INDEPENDENT AUDITOR'S REPORT

## to the Members of A Lust For Life

(A company limited by guarantee, without a share capital)

### Report on the audit of the financial statements

#### Opinion

We have audited the financial statements of A Lust For Life ('the company') for the year ended 30 June 2018 which comprise the Income and Expenditure Account, the Balance Sheet, the Reconciliation of Members' Funds, the Cash Flow Statement and the related notes to the financial statements, including a summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland".

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 30 June 2018 and of its deficit for the year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland"; and
- have been properly prepared in accordance with the requirements of the Companies Act 2014.

#### Basis for opinion







# **NOTES TO THE FINANCIAL STATEMENTS**

for the year ended 30 June 2018

### **1. GENERAL INFORMATION**

A Lust For Life is a company limited by guarantee incorporated in the Republic of Ireland. Canal House, 26 Grove Island, Corbally, Limerick, Ireland is the registered office, which is also the principal place of business of the company. The nature of the company's operations and its principal activities are set out in the Directors' Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

### **2. ACCOUNTING POLICIES**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### **Statement of compliance**

The financial statements of the company for the year ended 30 June 2018 have been prepared on the going concern basis and in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

#### **Basis of preparation**

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

#### **Income**

Turnover comprises the invoice value of goods and services supplied by the company, exclusive of trade discounts and value added tax.

#### **Trade and other debtors**

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

#### **Trade and other creditors**

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### **Taxation**

The organisation has been granted charitable tax exemption status under Sections 207 and 208 of the Taxes Consolidation Act 1997.

### **3. PROVISIONS AVAILABLE FOR AUDITS OF SMALL ENTITIES**

In common with many other businesses of our size and nature, we use our auditors to prepare and submit tax returns to the Revenue and to assist with the preparation of the financial statements.
